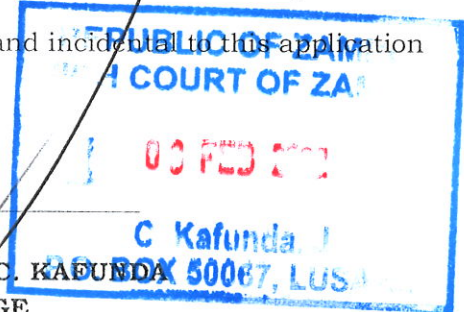


Luombwa River exceeding amounts stated in the water permit until the determination of this matter or until any further Order that this Court may make.
